A RESOLUTION/ORDINANCE TO ADOPT PROPOSED MODIFICATIONS TO THE FEE SCHEDULE REGARDING THE SOLID WASTE DISPOSAL RATES AND CHARGES OF THE HANCOCK COUNTY SOLID WASTE MANAGEMENT DISTRICT

WHEREAS, Village Vanlue (legislative authority) is located within the jurisdiction of the Hancock County Solid Waste Management District; and

WHEREAS, the Hancock County Solid Waste Management District Policy Committee prepared and adopted a resolution modifying Tier and Generation Fees to be collected on behalf of the Hancock County Solid Waste Management District.

WHEREAS, the District has provided a copy of said Resolution for ratification to each of the legislative authorities of the District; and

WHEREAS, the Township/Village of Vanlue (name of legislative authority) must decide whether it approves of said Resolution within sixty (60) days of receipt of the Resolution.

**RE: AUTHORIZING THE FINAL ADOPTION OF PROPOSED MODIFICATIONS TO THE FEE SCHEDULE REGARDING THE SOLID WASTE DISPOSAL RATES AND CHARGES OF THE HANCOCK COUNTY SOLID WASTE MANAGEMENT DISTRICT AT THE COUNTY LANDFILL.**

The Hancock County solid Waste Management District Policy Committee, Hancock County, Ohio ("the Committee") met in regular session on the 25th day of September, 2024, with the following Members present:

Ed Ingold, Lindsay Summit, Richard Kozlowski, Eric Swaisgood, Milford Smith, Michael Pepple and Rob Martin (proxy for Mayor Christina Muryn).

The Clerk advised the Board that the notice requirements of Section 121.22 of the Revised Code and the implementing rules adopted by the Board pursuant thereto were complied with for the meeting.

Milford Smith moved for the adoption of the following resolution:

**WHEREAS**, the Board of Hancock county Commissioners has established and maintains the District pursuant to Section 343.01 of the Ohio Revised Code, and is the owner and operator of the Hancock County Sanitary Landfill Facility located at 9763 County Road 140, Findlay, Hancock County, Ohio, (the "Landfill"); and

**WHEREAS**, on or about December 19, 2013 the Board did established a fee schedule for the Hancock County Landfill, and then, on or about January 28, 2014, and on or about February 15, 2015, amended portions of that fee schedule regarding charges for various services and various types of waste which are delivered to the Hancock County Landfill; and

**WHEREAS**, the Hancock County Landfill accepts solid wastes from Hancock County citizens, businesses, and others, collecting prescribed, established fees for materials delivered to the site of the Landfill; and

**WHEREAS**, the fees collected at the site have been set by the Hancock County Solid Waste Management District Board. Among the current fees charged are the sums of \$29.75 per ton for in-county tipping fees and \$31.75 per ton for out-of-county tipping fees; \$1.50 per ton for in-county tier fees and \$3.00 per ton for out-of-county tier fees; and \$1.50 per ton for Generation fees on all waste; and

**WHEREAS**, the SWMD Policy Committee has been informed that costs of the operation of the Landfill and recycling activities are expected to rise significantly in the immediate and longer-term future, and that an increase in tipping, tier, and generation fees would provide additional

Dear Trustees/Council Members,

The Hancock County Solid Waste Management District has approved an increase to the Tier and Generation fees collected on behalf of the Hancock County Solid Waste Management District. These increased fees will generate additional funding for local recycling efforts and education.

*As you may already know, the resolution must be ratified by the legislative authorities of the largest municipality in each county in the District and legislative authorities of townships and municipalities representing 60% of the population within the jurisdiction of the District.*

The Solid Waste Management District Policy Committee is providing you with a copy of the Resolution that was passed on November 20, 2024 during regular session. The District asks that you review the resolution at your earliest convenience. A resolution of your entity's support, or non-support, of the increase must be returned to the Solid Waste Management District at the address above within 60 days of the receipt of this notice. A sample resolution is enclosed for your convenience. Failure to respond within the 60 day timeframe will be considered a vote of support for the increase.
