

ORDINANCE NO. 2021-02

AN ORDINANCE AMENDING AND INCREASING THE APPROPRIATIONS FOR FUNDS #2021 AND Fund #5101 and DECLARING AN EMERGENCY BY INCREASING EACH FUND BY SAID VALUES LISTED BELOW.

BE IT ORDAINED by the Council of the Village of Vanlue, State of Ohio, Two-thirds (2/3) of all members elected thereto concurring:

SECTION 1: That said sum of an additional \$10,000.00 be and the same are hereby appropriated within the State Highway Fund (2021) for the purpose of repairing sidewalks along State Route 330.


SECTION 2: That said sum of an additional \$25,000.00 be and the same are hereby appropriated in the Water Fund (5101) for the purpose of paying liability insurance and unforeseen repairs

SECTION 3: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the inhabitants of the Village of Vanlue, Ohio and for the further reason it is immediately necessary to appropriate said funds so that the Village of Vanlue can pay said expenditures as they come due.

WHEREFORE, this Ordinance shall take effect and be in force from and after its passage and approval by the Mayor.
